
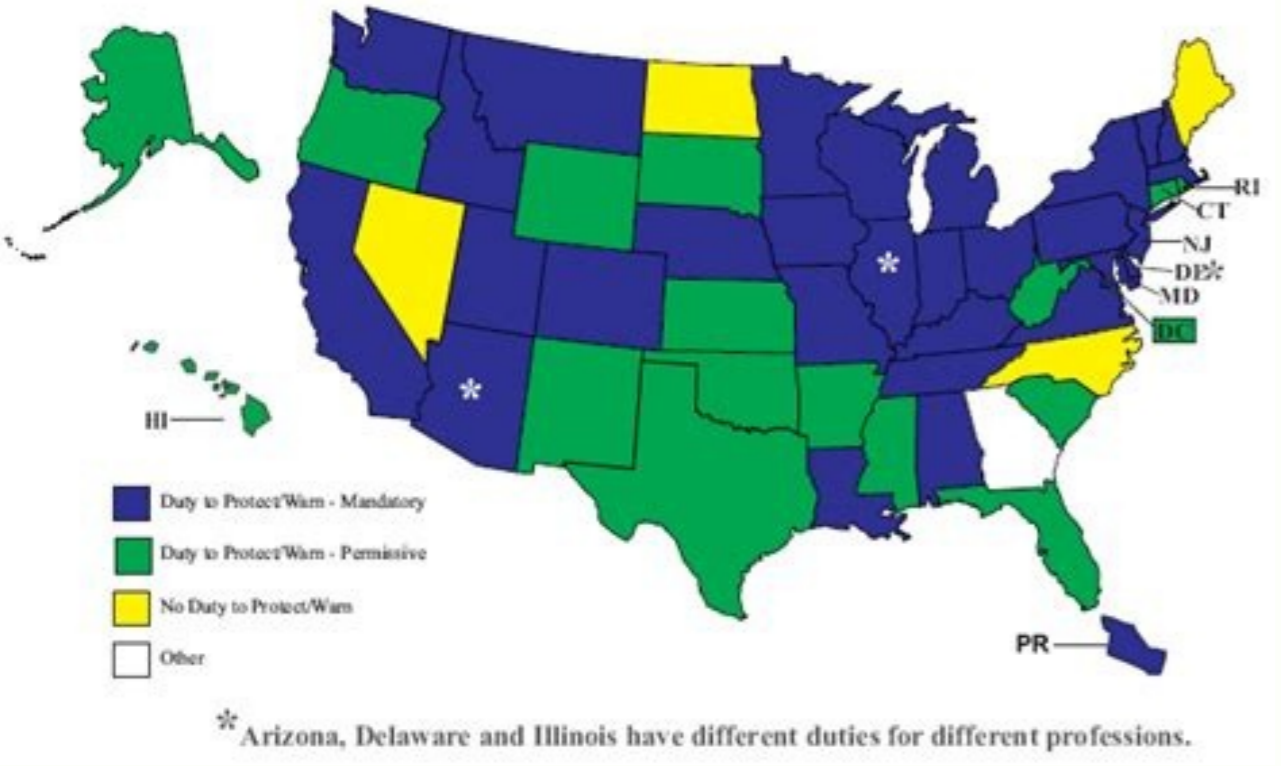
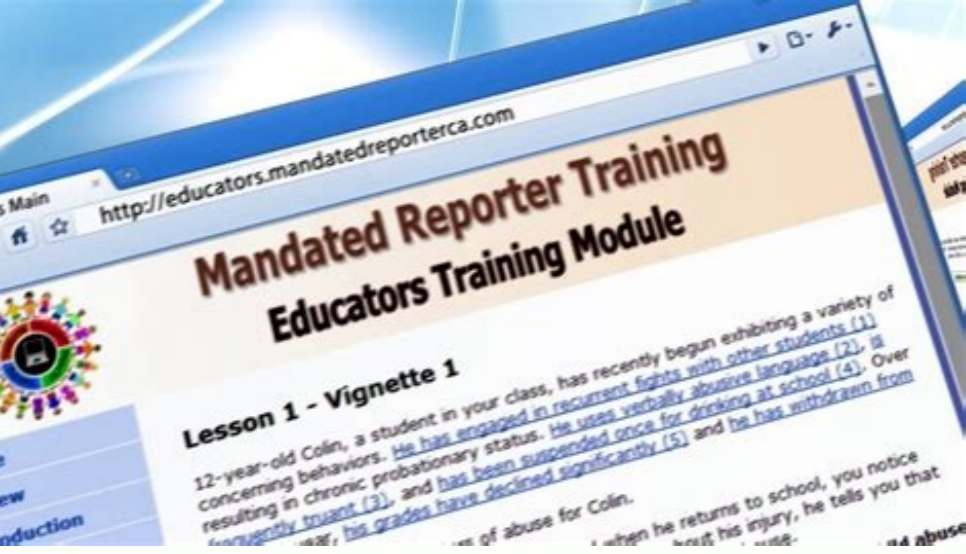
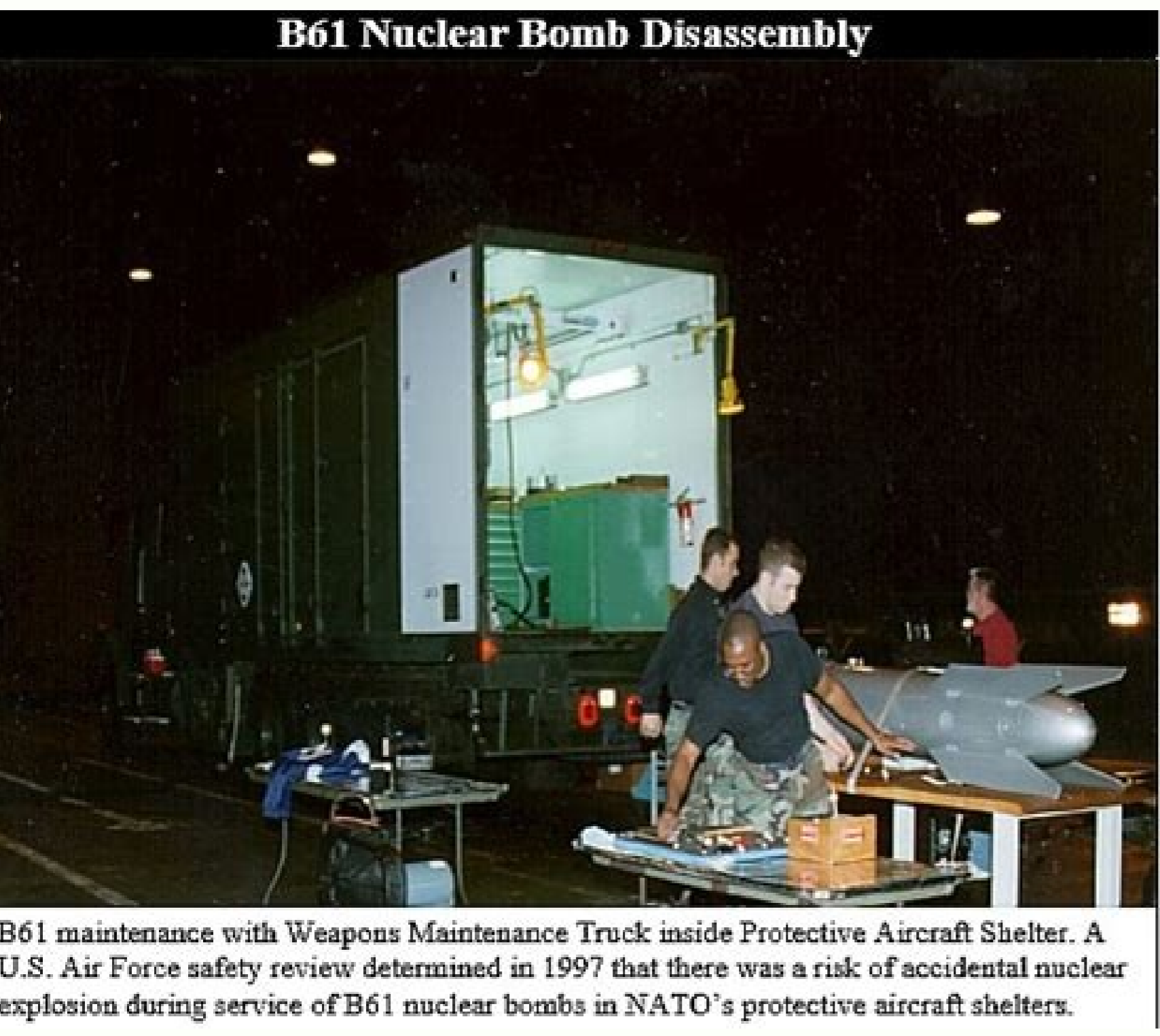

The purpose is that the laws encourage companies to engage in a healthy risk, but discourage them from lending to lending. Similarly, the laws provide that both the Company and its creditors must have an equal and correct involvement and contribution to solving the insolvency problem. It all depends on your perspective.
